

# Background information and documentation required for the preparation of the 2021 tax return

The tax return is in principle based on income realized throughout the year 2021 and all assets as of December 31, 2021. Please note the following exceptions:

- ✓ arrival in Switzerland or departure abroad during the year
- ✓ death of the taxpayer
- √ taxation of the surviving partner

Special rules apply; please contact us to discuss the implications.

The Swiss tax system is based on the principle of unlimited taxation of income and assets. This requires declaring **all income**, **whether realized in Switzerland or abroad**, as well as **all assets**, **whether held in Switzerland or abroad**, including income exempt from taxation by virtue of double taxation conventions concluded between Switzerland and third countries.

The second principle applicable in Swiss taxation is taxation of the family unit. Income from both spouses is added together, regardless of their matrimonial regime. Income and assets of minor children are declared in the parents' tax return.

Adult children, regardless of whether they are financially dependent, prepare their own tax return. Their fortune is declared in their own tax return and not in their parents' tax return.

Please note that the checklists are not necessarily complete and that they may be adapted or adjusted depending on your personal situation.

The categories followed by \*\*\* are particularly complex and may raise additional questions. In these cases, we recommend that you contact us to discuss your situation first, even before gathering the relevant documentation. This allows us to better guide you.

Finally and to the extent possible, we ask that you provide us with the complete **documentation** rather than with a summary.

- 2. the official 2021 tax return form
- 3. copy of your last tax return
- 4. copy of the last tax assessment ("décision de taxation")
- 5. 2021 account statement for cantonal/municipal tax installments ("relevé de compte BVR+")
- 6. the provisional bill for the 2021 federal direct tax ("bordereau provisoire")
- 7. statement of tax withheld at source ("impôt à la source")
- 8. a copy of the last US tax return for US citizens and green card holders
- 9. any other important transaction or relevant information
